National Eligibility-cum-Entrance Test – Post Graduate (NEET-PG)

New Delhi, India, 17 September 2016 –

The National Eligibility-cum-Entrance Test for entrance to MD/MS/PG Diploma Courses in terms of Section 10 of the Indian Medical Council Act, 1956 as amended in 2016 shall be conducted by the National Board of Examinations.

2. The examination shall be held in 86 test centers at 41 cities from December 5th – 13th, 2016. The examination shall be held as a Computer Based Test and shall comprise of 300 Multiple Choice Questions from the MBBS curriculum followed at medical colleges in India duly prescribed as per the Graduate Medical Education Regulation notified by Medical Council of India with prior approval of the Ministry of Health & Family Welfare, Government of India.
3. NEET-PG is a single window entrance examination for entry to MD/MS/Post Diploma courses. No other examination either at state level or institutional level entrance examination conducted by medical colleges /institutions shall be valid as per the Indian Medical Council Act, 1956 with effect from 2017 admission session.
4. Scope of Examination: NEET-PG 2017 shall be a single eligibility cum entrance examination namely 'National Eligibility-cum-Entrance Test for admission to Postgraduate Medical Courses' for the academic session 2017 which will include the following:
 - i. All India 50% quota seats for MD/MS/PG Diploma courses (all states except Andhra Pradesh, Jammu & Kashmir and Telangana)
 - ii. State quota seats for MD/MS/PG Diploma courses for all States/Union territories of India (including the states of Andhra Pradesh, Jammu & Kashmir and Telangana)
 - iii. MD/MS/PG Diploma courses at all Private Medical Colleges, Institutions & Universities/Deemed Universities all across the country
 - iv. MD/MS/PG Diploma courses at Armed Forces Medical Services Institutions.
 - v. DNB Broad specialty courses (January 2017 Admission Session)
5. The website for NEET-PG shall be available with effect from 24/09/2016 and online registration for the NEET-PG shall commence from 0700hrs on 26/09/2016 till 31/10/2016 (23:59hrs). The entire procedure for registration and application for the examination is online.

National Board of Examinations is an autonomous organization established by Government of India in 1982 with prime objective of conducting post graduate examinations on all India basis. National Board of Examinations also conducted the NEET-PG for MD/MS/PG Diploma admissions in 2013 and All India Post Graduate Medical Entrance Examination (AIPGMEE) during the period 2014 – 2016.

National Board of Examinations

(For admission to MD/MS/PG Diploma Courses - 2017 Session)

- **NEET-PG** is an eligibility-cum-ranking examination prescribed as the single entrance examination to various MD/MS and PG Diploma Courses as per Section (10) of Indian Medical Council Act 1956.
- **NEET-PG** is a single window entrance examination for PG courses. No other entrance examination, either at state or institution level, shall be valid for entry to MD/MS/Post Diploma Courses as per the Indian Medical Council Act, 1956.
- **National Board of Examinations** has been notified by the Ministry of Health and Family Welfare, Government of India to conduct **NEET-PG** on an All-India Basis for admission to various MD/MS and PG Diploma Courses at various medical colleges and institutions of the country.
- NBE shall be conducting **NEET-PG** as a Computer Based Test (CBT) from **5th - 13th December 2016** at test centres located in 41 cities across the country.

ELIGIBILITY CRITERIA FOR NEET-PG 2017

- Candidates in possession of MBBS degree/Provisional MBBS Pass Certificate from a Medical College/Institute duly recognized as per the provisions of the Indian Medical Council Act, possessing either a permanent or provisional registration certificate of MBBS or equivalent qualification issued by the Medical Council of India / State Medical Council and have completed one year of internship or are likely to complete the same on or before **31st March 2017** may apply for **NEET-PG** through online application system at www.nbe.edu.in

APPLYING FOR NEET-PG 2017

- Candidates can register for **NEET-PG** through online portal from **26th September to 31st October 2016**. Candidates can choose the exam centre and date through online registration system on first come first serve basis. Admit card will be sent to the candidates on their registered email ID after successful completion of online registration and payment of fees.
